With project complexity, dealing with people is very apparent, so developing skills and having a plan to communicate horizontally across the project team, the functional work streams and vertically with senior levels of management is paramount. Knowing what will be delivered, by when, by who, how etc., means effective scope definition and utilizing scheduling methods to gain agreement to proceed is essential for supporting project control. Plans must be realistic though and thought through risk management and contingency planning is necessary and essential. Finally executing the plans will involve reporting, managing issues and change control, before on completion, closing the project appropriately and learning lessons for the next project.
